# Annual Pass Terms and Conditions

By purchasing an Annual Pass you agree to accept the following terms and conditions:

1. An Annual Pass is valid for one person: either one Child being under the age of (16)/Concession or one adult (the "Member") to gain entry to Lee Valley Park Farms (the "Premises").
2. The Annual Pass shall be valid for one year from the date of purchase ("Period of Validity").
3. Each Pass Holder will be issued with their own Annual Pass.
4. The Annual Pass will contain basic details of the Pass Holder together with a photograph which will be a recent likeness of the Pass Holder.
5. The Annual Pass can only be used by the Pass Holder who is named and pictured on the file of the Pass Holder
6. The Annual Pass is non-transferable and non-refundable.
7. The Annual Pass remains the property of Lee Valley Leisure Trust and must not be defaced.
8. Subject to clause 11 & 12; an Annual Pass is valid for unlimited visits to the Premises for one full year from the date of purchase ("Period of Validity") during the Farm's open season that falls within the Period of Validity and any special events that may be held outside of the open season but within the Period of Validity subject to the normal terms and conditions of entry which can be found on our website.
9. An Annual Pass may be used for entry to the special events (subject to clause 11 & 12) held at the Premises which may include some events only open to Members.
10. At certain times and when advertised in advance on our website and detailing the applicable discount, the Annual Pass shall only permit the Pass Holder to a discounted entry fee to some of the special events.
11. Off Peak Passes only entitle the Pass Holder to unlimited visits to the Premises at Off Peak times (Monday to Friday School term time). During Standard times (Weekends, School Holidays & Bank Holidays) there will be a £3 charge per Off Peak Pass Holder
12. If the Premises is closed due to circumstances beyond Lee Valley Leisure Trust's control, Pass Holders are not entitled to a refund.
13. The Pass Holder must show their valid Annual Pass at the Lee Valley Park Farms reception on each visit and if asked by a member of Lee Valley Leisure Trust's Staff, you may be required to present additional photo identification.
14. Failure to present a valid Annual Pass will result in a charge of the daily admission rate which is non-refundable.
15. Misuse of the Annual Pass or failure to adhere to the Premises rules may result in the Annual Pass being withdrawn by Lee Valley Leisure Trust at their sole discretion and without a part refund being made.
16. All Pass Holders under the age of 16 years old must be accompanied by an adult on each visit to the Premises.
17. Lost Annual Passes must be reported to reception at Lee Valley Park Farms where there will be a £5 charge for replacement. 24 hours' notice is required in order to reissue lost or stolen Annual Passes.
18. Annual Passes can be purchased at the reception at Lee Valley Park Farms. Pass Holders can pay for Annual Passes via direct debit or in full via credit/debit card or in cash. Where a Pass Holder elects to pay their Membership fee by Direct Debit they commit to paying three (3) equal installments which will be collected over a consecutive three (3) month period.

19. Lee Valley Leisure Trust reserves the right to discount the cost of an Annual Pass without having to refund existing Pass Holders.
20. Annual Passes cannot be used in conjunction with vouchers or any other offer.
21. The purchase of an Annual Pass may entitle the holder to various Pass Holder benefits and where applicable, discounts, which may be offered by Lee Valley Leisure Trust from time to time.
22. No concession price can be offered over and above the price of the Annual Pass.
23. The data you supply will only be used for the purpose intended and not passed to any third parties.
